School Types Eligible for Our Program:

- Academic Curriculum—K-12
- Public Schools— Kindergarten, Elementary, Junior High, High School
- Private Schools— Kindergarten, Elementary, Junior High, High School
- Montessori Schools—K-12
- Charter Schools—experienced management; policies and procedures similar to public schools; prefer three years in operation
- Church Schools—established academic curriculum; account includes church
- Junior Colleges—Public or private
- Trade or Vocational Schools (depending on curriculum)
- PTAs/PTOs/Booster Clubs/Parent Organizations—designed primarily to support school functions, raise funds
- School Building Corporations
- Summer Athletic or Recreational Programs/Camps/Clinics—Offered by individual coaches who are regular school employees, provided we write school district; and using school property. BI and Med Pay for athletic participants excluded.
- Boarding or Rooming Houses—children and incidental class structure
- Fraternal Organizations—Fraternity and sorority houses, or similar organizations
- County/Township/Municipally Organized Amateur Athletic Programs (not directly associated with or sponsored by school district and/or conducted by individuals not employed by school)
- Social Services—County/Township/Municipal
- Big Brothers/Big Sisters and similar programs
- Apprenticeship Trade Programs—Often operated by trade union (carpentry, plumbing, etc.)
- Commercial Driver Training Entities
- Commercial Consultants—Business training programs

School Types Referred to Regional C/L Team:

- Sales, Service, or Consulting Organizations—Providing services, supplies, or food to school systems, but not part of school corporation
- Commercial Art Studios, Personal Enrichment Programs, or Clubs—Art, dance, photography, videography, music, etc.

School Types Not Eligible in Our Program:

- Day Care Operations—those with a minor “curriculum”
- Before & After School Programs—Separate entity essentially providing day care
